A. Governance & Dispute Resolution

1. This Agreement is made between the parties and governed by the laws of the State of Wisconsin.
2. Any disputes arising from the performance of either party shall be handled first by direct mediation in accordance with the policies and procedures of Fast Track, and if unresolved, second by the rules governing arbitration by the American Arbitration Association and/or Better Business Bureau, which shall be defined by jurisdiction and selected by Fast Track.

B. Authorization & Change Notices

1. Fleet Customer herewith authorizes Fast Track to perform services according to the terms provided hereinafter.
2. Fleet Customer herewith authorizes Fast Track to invoice for all services provided to its fleet of vehicles as authorized hereinafter.

D. Platinum Service Complete Oil Change

1. In consideration of payment Fast Track shall perform the following services, herein referred to as "Platinum Service Complete Oil Change," or "Platinum Service".
2. Namely, Platinum Service includes:

? change oil up to 6 quarts	? check & fill battery water
? install new oil filter	? check air filter & breather element
? lubricate chassis	? check & inflate/deflate tires to proper pressure
? check & fill transmission fluid	? check brake fluid
? check & fill differential fluid	? check wiper blades
? check & fill power steering fluid	? vacuum vehicle interior
? check & fill window washer fluid	? wash all window exteriors

E. Additional Services

1. Fleet Customer ? shall ? shall not permit drivers to authorize additional services, such as air filter replacement, differential and transmission service.
2. Fleet Customer shall limit additional services not to exceed \$_____. In cases where additional services shall exceed this limit, Fast Track shall contact the Fleet Customer Designee above by telephone for authorization to proceed.
3. Fleet Customer shall receive a 10% discount on all automotive services purchased

F. Representation of Fast Track ...

1. Represents that all work performed for Fleet Customer shall be performed in accordance with professional standards set by Lubricant Specialists LLC d/b/a Fast Track Lubricant Specialists, including, but not limited to, by trained preventive fluid maintenance specialist(s), and in accordance to meet or exceed manufacturer's specifications.
2. Represents that all work is performed in accordance with the laws of the State of Wisconsin.
3. Makes no other representations or warranties other than those expressed in this Agreement.

G. Representation of Fleet Customer

1. Fleet Customer shall pay for all services received and invoiced ? at time of service ? monthly within net terms extended.
2. Fleet Customer acknowledges that it is subject to all fees for collection of its account if it becomes delinquent over 30 days, including, but not limited to, late fees, interest at 1.5% per month, legal fees and attorney fees.
3. Late fees and interest charges shall not be assessed for accounts which are paid in a timely manner and not delinquent, i.e. over 30 days past due.

H. Non-Exclusive Agreement

1. By this Agreement the Fleet Customer does not represent nor agree to *exclusively* receive services from Fast Track, but acknowledges that this Agreement principally establishes a services -for-fee relationship which may or may not include discounts, credit terms, or other billing services.

I. Cancellation

1. Fleet Customer and Fast Track reserve the right to cancel this Agreement at any time without cause by written notice of not less than 30 days. Termination of the Agreement does not absolve the Fleet Customer for any unpaid amounts and collection fees, thereof.
